Multiple Clubs Join Together for ARRL Field Day 2025

Once again, three Pinellas County Amateur radio clubs joined forces for the annual ARRL Field Day event on June 28th & 29th, 2025 at the Clearwater Fire Training Center in Clearwater, Florida.



It would be somewhat trite to say we got the band back together for ARRL Field Day this year, but that is nonetheless what we did.

Members of SPARC teamed up with members from the Clearwater Amateur Radio Society and the Upper Pinellas Amateur Radio Club for the annual ARRL Field Day.

We have been at this facility before with both the other clubs for the most recent Winter Field Day in January and in years past. It is a wonderful facility and sharing the workload with the other clubs allows us to put on what I think is a better event.

As with other Field Days in the summer, we opted to set up temporary antennas but operated inside. We also used commercial power (since for a real emergency, we are well-versed in using the generators and the Clearwater EOC (*Emergency Operations Center*) which also has a generator).

We ran three stations plus the free VHF station for 6 meters and the satellite station. This all went to plan with the three UPARC Elecraft K3 radios, Paul KC4YDY ("6 meter Paul") Yaesu radio for 6m and the Icom IC-9700/Arrow antenna satellite station.

We scored the usual bonus points such as the natural power QSOs (contacts), a visit by a served agency (The

Pinellas County Sheriff's Office), passing the Field Day message to the Section Manager and copying the Field Day bulletin. We also sent ten NTS



(National Traffic System) messages from attendees and even had a youth contact. While we always get the media publicity bonus, this year thanks to the tenacity of Bruce K2BHS, we did it in style.

WFLA Comes to Town

Bruce, K2BHS joined the Field Day Planning Committee with the intention of acting as the public relations person. He sent invitations to various elected officials, served agencies and many media outlets. This paid off handsomely.



NBC affiliated TV station, WFLA (Channel 8) in Tampa, contacted Bruce saying that they wanted to do a live broadcast from our Field Day site on Sunday

morning starting at 6:00 AM. Yes, 6:00 AM on Sundaynot a typo. Reporter Jenna Bass and her photographer, Jamey Cicalese came out to the site and set up for their live shot. But it wasn't just one live shot. Bruce did three on-camera interviews. You can see one of those on our website www.sparc-club.org

We made over 2300 QSOs this year. The three HF stations stayed busy as did the 6-meter station.

• SSB (Phone): 1212


• CW (Morse Code): 401

ARRL Field Day 2025 Dry-Run Report

Members of the Clearwater Amateur Radio Society (CARS), St. Petersburg Amateur Radio Club (SPARC) and the Upper Pinellas Amateur Radio Club (UPARC) met at the Clearwater Fire Training Center on June 21 for the Field Day Dry-Run.

This is where we set up the radios and computers to ensure we have all the necessary equipment and cables for the following weekend's ARRL Field Day. While

neither the antennas nor coax were set up at that time, we performed a transmitter test on the Elecraft K3 radios, which will be used during the event, to



ensure they are transmitting full power.

We started at 9:00 AM and were able to finish up by 11:30 AM. It is a few well-spent hours to make sure we have all the little cables and other accounterment that radios and computers need to operate (microphones, CW keys, foot switch, USB cables, etc).

The dry-run was successful and everything was deemed operational in preparation for the following weekend's big event.

Who was WA4AKH: A Look into SPARC's Repeater Callsign

Anyone who frequently uses any or all of the St. Petersburg Amateur Radio Club's three repeaters, has

heard its ID, whether it is the CW (*WA4AKH/R*) or voice version. "*WA4AKH repeater*" The burning question in minds similar to mine is, "Who was WA4AKH? How did the repeaters get this call sign bestowed upon them." Prior to receiving its familiar WA4AKH callsign, the repeater was operating under the club callsign of no other than W4GAC.

So, first of all, who was WA4AKH? WA4AKH was no other than longtime trustee, Emmett West, who became a silent key in November 2007.

The newly formed SPARC Repeater Group, received a new license, with an initial callsign of KJ4DTL on April

28, 2007, as stated in the November 2008 edition of the *SPARC Gap*. Work was started almost immediately to obtain, Emmett's WA4AKH callsign under the FCC's Vanity Call Program, 100% backed by his widow, Marjorie T. West, WA4TVL (SK). Ms. West provided the group with a letter indicating her wishes and consent to have SPARC apply for Emmett's call. With the help of not only, Marjorie West – WA4TVL (SK), but Lu Romero – W4LT, Pete Petersen – KB9LXM (SK), Dee Turner – N4GD, Bill Zulas – WZ4GW, David Trewin – KR4U, Past President Leslie Johnson – WA4EEZ (SK) and Ron Hall – KP2N (SK), WA4AKH/R became a reality on July 25, 2008.

The first QSO on the newly licensed repeater was between Marjorie, WA4TVL and Dee, N4GD on SPARC's 440 MHz repeater. The source article states, "Marjorie's face lit up when the voice ID of WA4AKH came over her HT."

It is important to note that Emmett's memory has been honored for the past 17 years, as the SPARC repeaters' callsign.

Make Your Voice Heard with Regards to Restrictive HOA Rules

The American Radio Relay League (ARRL) launched a Nationwide Grassroots Campaign back in February 2025 for lawmakers in Washington, DC to pass the Amateur Radio Emergency Preparedness Act. This act would essentially give Amateur Radio Operators the same rights to install antennas on their property as those enjoyed by users of TV antennas, wireless internet, satellite dishes and flagpoles. The bipartisan House and Senate bills are aimed at preventing homeowners' association (HOA) rules that currently prohibit or severely limit the installation of amateur radio antennas. These restrictive HOA rules even stretch to the point of having these antennas hidden in trees, in your attic or even on your vehicle.

You are urged to make your voice heard! Only collectively, as the Amateur Radio Community, can we put an end to these oppressive restrictions. Remember that there is strength in numbers! The letter is predrafted and all you need to do is fill in some blanks. Those letters get sent to your local congresspeople and senators. SPARC's Occupancy of Current Meeting Place Terminates at the End of the Year

The St. Petersburg Amateur Radio Club has been notified by the owner of the DMI Research facility last month, that the club must vacate by the end of the year. Kathy, who is the owner of DMI Research cited a changing business model, that requires the space that SPARC currently occupies. She placed a move out date by the end of December 2025.

Club President, Tom Schaefer (NY4I) said that he received a text message from Kathy on Thursday, September 25, with the dreaded news. Tom further said that Kathy mentioned she is not selling the building. He also stressed that this action had nothing to do with anything the club may or may not have done as a tenant in the facility, it is just the changing business needs of the building's owner.

SPARC's Board held an informal information session via Zoom on September 29, to brainstorm ideas in the quest to securing, at the very least, a place to meet each month. He further mentioned that it would be ideal to secure a location where the club can have a shack as well. However, the most important thing is having a place to meet.

This development will be discussed in greater detail at the Monthly Meeting on October 3. Anyone that might have a "warm" lead of where we can hold our meetings is encouraged to advise accordingly. The membership will be notified once a new meeting (and maybe a club station) venue is secured. Stay tuned for future developments.
